DGFP STOCK STATUS REPORT
(For Contraceptives and DDS Kits)
Month: May 2016 (*Updated 26 June 2016*)

CONDOM – Current national stock is 164.84 million pieces and this stock can be used up to June 2017.

- FY 2014-15 GoB (Rev): Procurement Process completed for 150 million pieces and 119.92 million pieces received as of 30 April 2016; awaiting receipt 30.08 million pieces.
- Planned for FY 2015-16 GoB (Rev): 30 million pieces.

PILL – Current national stock of Oral Contraceptive Pill is 101.55 million cycles which will go up to April 2017.

- 2014-15 (Pool fund): Procurement Process completed for 60m cycles (ICB) & 18 m cycles (NCB): 54.94 million cycles received as of 30 April 2016; awaiting receipts 23.06 million cycles.
- Planned for 2015-16: Pool Fund: 45 million cycles

IUD – Current national stock is 0.669 million pieces and this stock can be used up to February 2019.

- FY 2013-14 (Pool fund) -0.04 million pieces - Contract signed and awaiting receipts.

INJECTABLES – Current stock of 17.22 million vials and that can be used up to August 2017.

- Procurement Process completed for 2014-15: Pool fund - 14m vials (ICB) & GoB Dev- 2.5m vials (NCB): 11.9 m received as of 30 April 2016; awaiting receipt 8.1m.
- Planned for 2015-16: Pool fund - 7m vials (ICB) & GoB Dev - 3.5m vials (NCT).

IMPLANT – Current stock is 0.298 million sets and this can be used up to February 2017.

- Planned for 2015-16: (Pool fund) 0.15m sets.

***DDS KITs**

- 2014-15: Pool fund - 0.070m boxes: World Bank did not accord No Objections on Bid Evaluation Report (BER) for this procurement.
- 2015-16: GoB (Dev) – 3,600 boxes (NCB) – All quantity received.
(*The medicines under DDS Kit are not going to be procured in Kit form. Instead, individual medicines of 22 items will be procured from now on)
