

## **DGFP STOCK STATUS NOTES**

## (For Contraceptives) Month: April 2021

**CONDOM** – Current national stock is 88.88 million pieces and this stock can be used up to March 2022.

- 2019-20: GoB (Rev.) 175.75 million pcs: DGFP received total 175.75 million as of 31<sup>st</sup> March 2021.
- 2020-21: GoB (Rev.) 67 million pcs. (Revised plan): IFT published on 05-08-2020, tender opened on 17-08-2020, TEC meeting held on 31-08-2020 and contract signed on 08/10/2020. Goods will be delivered from May 2021 and onward.
- PILL Current national stock of Oral Contraceptive Pill is 123.24 million cycles which will go up to December 2022.
  - 2020-21: GoB (RPA) 22.47 million cycles (2<sup>nd</sup> Generation): Tender rejected and IFT (Retender) published on 18-11-2020 and TOC held on 02-12-2020. TEC held on 06/01/2021. Proposal Send to ministry for approval on 07-02-2021. Proposal approved by the ministry & contract signed on 29-03-2021. Goods will be delivered from May 2021 and onward.
  - 2020-21: GoB (RPA) 54.5 million cycles (3<sup>rd</sup> Generation): 1<sup>st</sup> and 2<sup>nd</sup> TEC meeting held on 12/10/2020 and 20/10/2020 respectively. Send to CCGP through ministry for approval on 22-11-2020. Proposal approved by CCGP on 23/12/2020. Contract signed on 11/01/2021(For Lot-01) and 18/01/2021(For Lot 02 & 03). DGFP received 43.59 million as of 30<sup>th</sup> April 2021. Rest 10.91 million is scheduled to deliver to DGFP from May 2021 and onward.
  - 2020-21: GoB (RPA) 4 million cycles (POP Apon): IFT published on 02-09-20 and Tender opened on 30-09-20. TEC meeting held on 19-10-20. NOA issued on 15-11-2020. Contract signed on 09/12/2020. DGFP received the total quantity in February 2021.
  - 2020-21: GoB (Rev.) 31m (2<sup>nd</sup> Generation): Contract signed on 15/10/2020. DGFP received all 31 million cycles as of 31<sup>st</sup> January 2021.
  - 2020-21: GoB (Rev.) 6 million (3<sup>rd</sup> Generation): Contract signed on 14/10/2020. DGFP received total 6 million cycles in November & December 2020.
  - 2020-21: GoB (Rev.) 0.5 million cycles (POP- APON): Contract signed on 04/10/2020. DGFP received the total quantity in November 2020.
- IUD Current national stock is 0.570 million pcs and this stock can be used up to November 2024.

INJECTABLES – Current stock of 29.34 million vials and that can be used up to April 2024.

- 2020-21: GoB (RPA) 14 million vials: IFT published on 16-09-2020. TEC held on 28-10-2020, Send to ministry on 05-11-2020 for approval. Contract signed on 14/12/2020. DGFP received total 14 million in January & February 2021.
- 2020-21: GoB (Rev.) 2 million vials: Contract signed on 07/10/2020 and DGFP received full quantity as of 31st October 2020.

**IMPLANT** – Current stock is 0.108 million sets and this can be used up to July 2021.

- 2019-20: GoB (RPA) 300,000 sets (Two rods Revised plan): TEC held on 17-02-2021 and tender rejected again on 22-02-21 for 3<sup>rd</sup> time. And again IFT published on 25/02/2021 as retender 4<sup>th</sup> time. Tender opened on 31<sup>st</sup> March. TEC held on 11-04-2021 & 20-04-2021, evaluation completed and sent to MOHFW for review and approval.
- 2020-21: GoB (RPA)–0.275 million sets of single rod implant plan approved by DG. IFT published on 05-10-2020. Tender opened on 19-11-2020. Tender rejected due to not dropping by any vendor.
- 2020-21: GoB (RPA) 0.275 million sets of two rod implant plan approved by DG. IFT published on 18-01-2021. Tender opened on 08-03-2021. TEC held on 14-03-2021 & 28-03-2021, evaluation completed and MOHFW has given approval on April 28, 2021. NOA issued on 29/04/2021.
