

**CONDOM** – Current national stock 283.7 m and this stock can be used up to January 2015. FY 2011-2012 GoB 150m out of which 145 m received as of 31 December 2012; 5.0m yet to receive.

**PILL** – Current national stock of pill is 156.4 m cycles which will go up to May 2014.FY 2011-12 pool fund 150m out of which 116.2m received as of 31 December 2012; 33.8m yet to receive.2012-13 Pool fund 150m: Bid Evaluation Report sent to WB for NOC on 18 December 2012.





#### Stock Status at Upazila Store and Field on December 2012






Month wise consumption from December 2011 up to December 2012






Month wise consumption from December 2011 up to December 2012




